In producing herewith the arrested accused persons namely 1) Afroj Ansary (20 yrs) 5/o- Muktar Ansary of Darda, PS- Para, Dist- Purulia, 2) Kanai Gope (33 yrs) 5/o- Jagannath Gope of Vill- Bhanderkuli, PS- Para, Dist-Purulia and one seized vehicle (Tata ACE) bearing Regn No- JH09AE 6191 loaded with 40 packet potatoes.

1515huvankar Sarkar, In-Charge Santaldih IC BCW under Santaldih PS do hereby lodge complaint suomoto against the arrested accused persons namely 1) Afroj Ansary (20 yrs) 5/o- Muktar Ansary of Darda, PS- Para, Dist-Purulia, 2) Kanai Gope (33 yrs) S/o- Jagannath Gope of Vill-Bhanderkuli, PS- Para, Dist-Purulia and 3) Owner of the vehicle (Tata ACE) bearing Regn No JH09AE 6191 loaded with potato and others. I would like to note here that today i.e on 17.08.2024 at 14:05 hrs myself along with C/948 Ramen Pramanick, C/1364 Atanu Manna all are of Santaldih IC BCW who were already engaged in mobile duty were performing duty at Santaldih IC BCW area under Santaldih PS vide Santaldih IC BCW GDE No 316/24 dated 17:08:2024 and Santaldih IC BCW C.C No 1326/24 dated 17:08:2024. At 16:15 hrs found a Tata ACE Vehicle was coming from Cinematala side through with high speed. We signaled the driver to stop the vehicle. But the driver of the vehicle did not pay any heed. He accelerated the speed of the vehicle and fled away with the vehicle in rash and negligent manner after dashed the on road guardrail. We chased the vehicle. After a hot chase we could be able to intercept the vehicle near Gosaidih @ Dupkati more at 16:25 hrs. The driver of the vehicle tried to fice away by keeping the vehicle on road. But we chased him and able to intercept him as well as intercepted the khalasi of the vehicle. We checked the vehicle carefully and found registration no of the vehicle (Tata ACE) was JH09AE 6191 and the said Tata ACE was loaded with potato. On asked they disclosed their identity as Afroj Ansary (20 yrs) S/o- Muktar Ansary of Darda, PS- Para, Dist- Purulia driver of the said vehicle and Kanai Gope (33 yrs) S/o- Jagannath Gope of Vill- Bhanderkuli, PS- Para, Dist- Purulia Khalasi of the said vehicle . I asked the driver and Khalasi to produce any valid document in respect of the vehicle bearing registration No JH09AE 6191 as well the potato loaded in it. But they could not able to produce any document. On asked the driver and Khalasi stated that they were carrying approx 40 Packets potatoes by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State.

So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said potatoes by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business.

Finding no other alternative, I seized the vehicle bearing Regn No JH09AE 6191 along with 40 packet potatoes loaded in it from the possession of the Driver and Khalasi under proper seizure list duly signed by the witnesses. The seizure procedure was done in between 16:40 hrs and 17:05 hrs. Then I arrested both the accused persons namely I) Afroj Ansary (20 yrs) S/o- Muktar Ansary of Darda, PS- Para, Dist- Purulia, 2) Kanai Gope (33 yrs) S/o- Jagannath Gope of Vill- Bhanderkuli, PS- Para, Dist- Purulia after preparing proper arrest memo as they have committed offence U/S -303(2)/ 317(2)/281 BNS and 3 PDPP Act after maintaining all the formalities as per NHRC guide line.

The Audio & Videography of entire processes of search and seizure has been done. The videography has been stored in compact disk which is enclosed here with.

Under the above circumstances, I pray before you to start a specific case against the arrested accused person namely 1) Afroj Ansary (20 yrs) S/o- Muktar Ansary of Danda, PS- Para, Dist- Purulia, 2) Kanai Gope (33 yrs) S/o-Jagannath Gope of Vill- Bhanderkuli, PS- Para, Dist- Purulia 3) Owner of the vehicle (Tata ACE) bearing Regn No JH09AE 6191 loaded with 40 packet potatoes and others under proper sections of law.
