Prayer to lodge FIR. Sub:-

Sir. In producing herewith the arrested accused persons namely 1) Alisaffan Khan (M/20 yrs), S/O Lt. Harun Khan of Vill. - Rageridh, & 2) Sk. Antaz (M/38 yrs), S/O Ilias Sk. of Kolagara, both of PS - Raghunathpur, Dist-Purulia and one seized vehicle (Tata ACE) bearing Regn No- WB81-0268 loaded with 06 (Six) cow (5 male & 01

I SI Bamdeb Sinha of Santaldih PS do hereby lodge complaint suomoto against the arrested accused persons namely 1) Alisaffan Khan (M/20 yrs), S/O Lt. Harun Khan of Vill. - Rageridh, & 2) Sk. Antaz (M/38 yrs), S/O Ilias Sk. of Kolagara, both of PS - Raghunathpur, Dist- Purulia and 3) Owner of the vehicle (Tata ACE) bearing Regn No WB81-0268 . I would like to note here that today i.e on 27.08.2024 myself along with C/1556 Faizul Kabir & HG/317 Gambhir Mahato who were already engaged in evening mobile duty at PS area vide Santaldih PS GDE No 1063 dated 27.08.2024. During evening mobile duty at 17.15 hrs received source information that one vehicle loaded with cow are coming from Darda side without any valid documents or proper permission from concerned authority. The matter was informed to I/C Santaldih PS and as per his kind instruction I along with force started naka checking at Paharigora more after placing guardrail. At 17.35 hrs I stopped one vehicle (Tata ACE) bearing Regn No- WB81-0268 and found that total 06 (Six) cow (5 male & 01 female) were loaded in the above mentioned vehicle.

On being asked the driver & Khalasi of the said vehicle disclosed their identity as 1) Alisaffan Khan (M/20 yrs), S/O Lt. Harun Khan of Vill. - Rageridh, & 2) Sk. Antaz (M/38 yrs), S/O Ilias Sk. of Kolagara, both of PS -Raghunathpur, Dist- Purulia. On demand they could not produce any papers in respect of the said vehicle and about the procurement of the cow. Not only that they have not any paper regarding transportation of cow. The vehicle is not meant for transporting livestock as no livestock permit was available they did not give satisfactory reason for transporting of cow by vehicle. They have stated in coherently and from there statement there is every reason to believe that they have procure the vehicle and the cow in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those cow for personnel gain with the help of the owner the vehicle bearing Regn No- WB81-0268. Moreover they were carrying those cow in the vehicle in such a manner that those cow were concealing together for the want of space. The above noted accused persons treated the cow in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breath. Hence I seized those 06 (six) cow and the vehicle noted above from the possession of above noted accused persons under proper seizure list with proper videography duly signed by the witnesses as well as accused persons. I also arrested the above noted accused persons as they committed offence U/S 303(2)/317(2)/317(5)/61(2) BNS & R/W section 11(1) (d) (e)(f) the prevention of Cruelty to Animal Act, 1960. After that I brought the arrested accused persons by maintaining all formalities regarding arrest with the help of my accompanied force. The vehicle is not meant for transporting the cow.

Under the above circumstances, I pray before you to start a specific case against the arrested accused persons namely 1) Alisaffan Khan (M/20 yrs), S/O Lt. Harun Khan of Vill. - Rageridh, & 2) Sk. Antaz (M/38 yrs), S/O llias Sk. of Kolagara, both of PS - Raghunathpur, Dist- Purulia & 3) Owner of the vehicle (Tata ACE) bearing Regn No WB81-0268 U/S 303(2)/317(2)/317(5)/61(2) BNS & R/W section 11(1) (d) (e)(f) the prevention of Cruelty to Animal Act, 1960.
