Sub: Unlawful entry into my house, beating, threatening to kill me And Stolen Academic certificate.

Respected Sir;

My humble submission is to you that Iam Akhtar Hussain Ansari residing at C/O-Abdul Rejak Ansari ,Vill-Kanki Bazar,P.O-Bogra,P.S-Santaldih,Dist-Purulia,Pin-723145.

Details of the incident:-

On 12 July 2024 around 5.30pm, Mr.Halim Ansari misused his influence, money, and muscle power and illegally enter into my house with his family members Sk. Ruksar, Sk. Nasrin, Sk. Rojina, Sk.Intaz and started beating on my head by fist and pulling my testicles.

I fell down on the ground and fainted and when I recovered I saw that they had taken around 20K (Twenty Thousand)money& all my academedic certificates from my house. I have informed the incident to the police station same day.

On 09th August 2024 around 6 pm Mr.Halim Ansari and Sk. Ruksar came to my house and abused me in profanity and threatened if you tell the matter to the police, I will shoot you dead. MP, MLA, the Police all are in my pocket.After this incident, I lost my mental balance.

On 10th August morning around 8.30 am the police came to my house after receiving information from any sources and wants to know the incident details from me.At that moment I was thinking of Halim Ansari's threat and not being able to tell the details of the incident to the police officer to avoid further trouble on my family.

On same day at 4 pm Mr. Halim Ansari, Sk. Rojina, Sk. Ruksar, Sk. Nasrin, Sk. Dipu, Sk. Intaz forcefully entered into my house. They started beating repeatedly with there fist, hitting my body and the private part with support of Sk. Rojina, Sk. Ruksar, Sk. Nasrin, they threatened and left. On same day after treatment at the Para (BMOH) Hospital, I kept quiet in fear.

Again, on 14th August Mr.Halim Ansari and Sk. Ruksar became fearless and came to my house around 8 o'clock on Wednesday night and threatened me again and again.

I live alone at home in fear with my sick father (70 yrs) who is suffering from severe kidney decease. They are too powerful to kill me anytime.

Finding no other alternatives and being frustated the matter is placed before your honour for proper redress.

So, I request you to investigate the matter and take the appropriate legal action against the guilty persons as soon as possible.
