Dear Sir/Madam,

I, Samim Ali Molla, S/O- Sabed Ali Molla, the A.E. & Station Manager of Santuri Customer Care Centre being authorized under the electricity Act.-2003 and electricity (Amendment) Act-2007, do here by lodge complaint against Rakhadeb Gupta, S/O- Late Bisheshwar Gupta, Village- Muradih, P.S.- Santuri for theft of electricity by tampering the service cable of the Energy meter by bypassing the energy meter of WBSEDCL with the help of PVC cable U/S.- 135(i)/(b) of electricity Act 2003 and electricity (Amendment) Act-2007, as Stated here under. Please be noted that that, the service connection having con id:242040914 is in the name of Amala Bala Gupta and the present user is Rakhadeb Gupta.

That on 28.08.2024 at 03.15 PM myself along with Sri Partha Chakraborty, DE(S & LP) of Purulia Region Office, Sri Prasanta Maji Junior Engineer(E) Gr.-1, Raktim Roy (Sr. Office Executive) of Santuri CCC inspected the domestic premises of Rakhadeb Gupta, S/O- Late Bisheshwar Gupta, Village- Muradih, P.S.- Santuri and it is found that, electricity is used at his premises for running his domestic electrical appliances by tampering the service cable of the Energy meter by bypassing the energy meter of WBSEDCL. Inspection report have been prepared and assessed the load which comes to 2.865 KW. After disconnection of the service connection having con id:242040914 by maintaining proper safety norms, Single core two wire Al. PVC cable of approx. 4ft(Part of the service cable) jointed with one no Single core two wire Al. PVC cable of approx. 2ft and one no Single core two wire Al. PVC cable of approx. 1.5ft have been seized under proper seizure list. The premises have been left at 04:00 pm. It may also be noted that, another service connection having Con id:204021839 also exists in the name of Rakhadeb Gupta in the same premises which also been disconnected.

Hence, Rakhadeb Gupta, S/O- Late Bisheshwar Gupta, Village- Muradih, P.S.- Santuri has committed theft of electricity and are liable to be prosecution U/S.- 135(1) (b) of electricity Act-2003 and electricity (Amended) Act-2007.

Please treat this complaint as FIR and do the needful.
