In producing herewith the arrested accused persons namely 1) Ainul Ansary (25 yrs) S/O- Lt. Ayub Marhum of Vill- Pandri, PS- Chano, Dist- Ranchi, (Jharkhand), 2) Azaz Ansari (23 yrs) S/O- Samim Ansari of Vill- Pandri, PS- Chano, Dist- Ranchi (Jharkhand) and one seized vehicle (Truck) bearing Regn No CG 14 MD 5550 loaded with 500 packet potatoes.

I SI Biswajit Mondal, OC Santuri PS do hereby lodge complaint suomoto against the arrested accused persons namely 1) Ainul Ansary (25 yrs) S/O- Lt. Ayub Marhum of Vill- Pandri, PS- Chano, Dist- Ranchi, (Jharkhand), 2) Azaz Ansari (23 yrs) S/O- Samim Ansari of Vill- Pandri, PS- Chano, Dist-Ranchi (Jharkhand) and 3) Owner of the vehicle (Truck) bearing Regn No CG 14 MD 5550 loaded with potato and others. I would like to note here that today i.e on 09.08.2024 at 03:05 hrs myself along with ASI Suvendu Maity, C/1393 Tapas Ghosh, C/1506 Chanchal Singh all are of Santuri PS who were already engaged in night mobile duty were performing Naka checking duty at Hansdima morh under Santuri PS vide Santuri PS GDE No 303/24 dated 09.08.2024 and Santuri PS C.C No 2465/24 dated 08.08.2024 . At 03:35 hrs found a truck was coming from Saltora side through SH 8 with high speed. We signaled the driver to stop the vehicle. But the driver of the vehicle did not pay any heed. He accelerated the speed of the vehicle and fled away with the vehicle in rash and negligent manner after dashed the on road guardrail. We chased the vehicle. After a hot chase we could be able to intercept the vehicle near Santuri PS on SH 8 at 03:45 hrs. The driver of the vehicle tried to flee away by keeping the vehicle on road. But we chased him and able to intercept him as well as intercepted the khalasi of the vehicle. We checked the vehicle carefully and found registration no of the vehicle (Truck) was CG 14 MD 5550 and the said truck was loaded with potato. On asked they disclosed their identity as Ainul Ansary (25 yes) S/O- Lt. Ayub Marhum of Vill- Pandri, PS- Chano, Dist- Ranchi, (Jharkhand) driver of the said vehicle and Azaz Ansari (23 yrs) S/O- Samim Ansari of Vill- Pandri, PS- Chano, Dist- Ranchi (Jharkhand) Khalasi of the said vehicle. On asked the driver stated that they were carrying approx 500 Packet potatoes which was loaded somewhere in Joypur, Bankura district. I asked the driver and Khalasi to produce any valid document in respect of the vehicle bearing regn No CG 14 MD 5550 as well the potato loaded in it. But they could not able to produce any document.

Hence there was every reason to believe that the driver, Khalasi of the above noted vehicle in connivance with the owner of the vehicle bearing Regn No CG 14 MD 5550 and others are carrying potatoes illegally. Thus they are running this clandestine business.

Finding no other alternative I seized the vehicle bearing Regn No. CG 14 MD 5550 along with 500 packet potatoes loaded in it from the possession of the Driver and Khalasi under proper seizure list duly signed by the witnesses. The seizure procedure was done in between 04:25 hrs and 07:05 hrs. Then I arrested both the accused persons namely 1) Ainul Ansary (25 yrs) S/O- Lt. Ayub Marhum of Vill-Pandri, PS- Chano, Dist- Ranchi, (Jharkhand), 2) Azaz Ansari (23 yrs) S/O- Samim Ansari of Vill-Pandri, PS- Chano, Dist- Ranchi (Jharkhand) after preparing proper arrest memo as they have committed offence U/S -303(2)/317(2)/281 BNS and 3 PDPP Act after maintaining all the formalities as per NHRC guide line.

I would like to note here that as we intercepted the above noted vehicle on SH 8 which is a busy road. Vehicles were moving continuously and there was no sufficient place to unload approx 500 packet of potatoes(as stated by the driver) by side of the road. Hence I brought the above noted potato loaded truck and detained driver and khalasi of the above noted vehicle inside the PS compound. Entire seizure and arrest procedure was done in Santuri PS compound in presence of witnesses under videography.

The Audio & Videography of entire processes of search and seizure has been done. The videography has been stored in memory card which is enclosed here with.

Under the above circumstances, I am starting a a specific case U/S -303(2)/ 317(2)/281 BNS and 3 PDPP Act against the arrested accused person namely 1) Ainul Ansary (25 yrs) S/O- Lt. Ayub Marhum of Vill- Pandri, PS- Chano, Dist- Ranchi, (Jharkhand), 2) Ezaz Ansary (23 yrs) S/O- Samim Ansary of Vill- Pandri, PS- Chano, Dist- Ranchi (Jharkhand), 3) Owner of the vehicle (Truck) bearing Regn No CG 14 MD 5550 loaded with 500 packet potatoes and others and endorsed the case to SI Partha Sarathi Shit of Santuri PS for its investigation.
