Sub: Complaint against Ranjit Gorai (27 Yrs), S/O- Ananda Gorai of Vill-Dandahit, P.S - Santuri, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accuse 1 person namely Ranjit Gorai (27 Yrs), S/O- Ananda Gorai of Vill-Dandahit, P.S - Santuri, Dist - Purulia along with 25 (Twenty five) bottles Country Sprit styled as "Dil Kush" each bottle containing 600 ml Dil Kush seized under proper seizure list, I beg to submit that today (13.08.24), I along with force while performing evening mobile duty at about 17:45 hrs received a credible source information that one person Ranjit Gorai (27 Yrs), S/O- Ananda Gorai of Vill-Dandahit, P.S - Santuri, Dist - Purulia was stocking and selling Country Sprit styled as "Dil kush" without any valid documents/license from his house at Vill- Dandahit, P.S - Santuri, Dist - Purulia. I informed to OC Santuri PS about this matter & as per direction, I along with force reached at his house of Ranjit Gorai at about 18:05 hrs at Dandahit village to work out the source information and held raid there. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person was stocking Country sprit styled as "Dil Kush" for sell. On demand, he failed to produce any valid documents/ license in respect of selling and stocking of Country Sprit. Accordingly, I seized and labeled 25 (Twenty five) bottles country sprit styled as "Dil Kush" containing 600 ml each bottle under proper seizure list duly signed by the witnesses out of which one bottle sealed and labeled as sample. Then, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Ranjit Gorai (27 Yrs), S/O- Ananda Gorai of Vill-Dandahit, P.S - Santuri, Dist - Purulia.
