I, Anup Roy S/O- Ajit Kr. Roy of Vill- Paira, P.O- Simlapal, PS- Hirbandh, Dist-Bankura, at present posted at Tamna PS, Dist- Purulia, as ASI of Police producing herewith one arrested accused person namely Falari Mahato (65 yrs) S/O- Lt.
