Lachhman Dass, Station Manager of Chakda CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Bhusan Chandra Mahato C/O Budhu Mahato of Vill - Simulia, PS- Tanna has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 14.08.2024 I, Gotirmoy Dass (SM), along with Sri Indrajit Sinha JE (GR-I) & Sri Brikodhar Mahato (Supervisor LT Mobile Van staff) of Chakda CCC, WBSEDCL, conducted a raid programme at village Simulia under Tanna P.S. When our team at about 01.40 pm entered to the Domestic premises of Bhusan Chandra Mahato, we found that he was enjoying electricity dishonestly by means of Meter Bypass by means of Meter bypassing by way of tampering service cable and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable with bypass arrangement and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 2.00 pm after completion of inspection & necessary formalities.

Bhusan Chandra Mahato C/O Budhu Mahato of Vill - Simulia, PS- Tanna has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
