Respected Sir,

I, Madhusudan Das S/o- Lt. Dhaneswar Das Vill- Dhabadih, PO- Purulia, PS- Purulia(T), Dist- Purulia, at present posted at Tamna PS, Dist- Purulia, as ASI of Police producing herewith one arrested accused person namely Padmalochan Sardar (60 yrs) S/O- Arun Sardar of Vill- Raibandh, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). One white colour plastic jerican containing approx 08 Ltrs. ID Liquor, 2) 05 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (25.08.2024) during my PS area evening mobile duty received a secret source information that one person is selling I.D Liquor at Ambagan near Raibandh more under Tamna PS, so myself along with i) C/1455 Sudhangsu Kuiry & ii) C/138 Bani Bandhapadhyay both of Tamna PS came to the spot at about 19:45 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Padmalochan Sardar (60 yrs) S/O- Arun Sardar of Vill- Raibandh, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of selling of ID liquor. As such I seized 1). One white colour plastic jerican containing approx 08 Ltrs. ID Liquor, 2) 05 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses which was duly videographed. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Padmalochan Sardar (60 yrs) S/O- Arun Sardar of Vill- Raibandh, P.S- Tamna, Dist- Purulia as per proper section of law.
