Lachhman Dass, Station Manager of Chakda CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Akbar Sai C/O Samir Sai of Vill - Damda, PS- Tamna has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 14.08.2024 I, Gotirmoy Dass (SM), along with Sri Indrajit Sinha JE (GR-I), & Sri Brikodar Mahato (Supervisor LT Mobile Van staff) of Chakda CCC, WBSEDCL conducted a raid programme at village Damda under Tamna P.S. When our team at about 12.05 pm entered to the Domestic premises of Akbar Sai, we found that he was enjoying electricity dishonestly by means of Meter Bypass by means of Meter bypassing by way of tampering service cable and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable with bypass arrangement and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 12.20 pm after completion of inspection & necessary formalities.

Akbar Sai C/O Samir Sai of Vill - Damda, PS- Tamna has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
