I Sri Gotirmoy Dass, S/O - Lt Lachhman Dass, Station Manager of Chakda CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Sri Kalachand Sahis S/O Lt. Kushal Sahis of Vill - Mishirdih PS- Tamna has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 27.08.2024 I. Gotirmoy Dass (SM), along with Sri Indrajir Sinha JE(E) Gr-I & Sri Shyamapada Mahato(Sr. TSH) of Chakda CCC, WBSEDCL conducted a raid programme at village Mishirdih under Tamna P.S. When our team at about 01.40 pm entered to the Domestic premises of Sri Kalachand Sahis, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest LTOH line and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.50 pm. after completion of inspection & necessary formalities.

Sri Kalachand Sahis S/O Lt. Kushal Sahis of Vill - Mishirdih, PS- Tamna has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
