Sir,

In producing herewith the 01 (One) arrested accused persons namely (1) Md.Imran (32 Yrs) S/O- Md.Sahid of Vill- Kamalasthan, PS-Adra. Dist-Purulia, and other 07(Seven) to 08(Eight) unknown person along with owner of the place(whom fled away from the spot) brought under seizure (i) 01 (One) Frontech-SKU Black Colour Monitor, 0060(55.88 CM) (ii) 01 (one) Silver blackish colour HP CPU, No-00070014 Saraswat Co-operative bank limited (iii) (one) Zebronics Black Colour Mouse, (iv) 01(One) EPSON Black color Printer, TM-T88 IV-272 model no - M129H with Sl no RHKFOO1862 (v) One AC/DC Adapter HP-PN 586992 (vi) One AC Adapter Epson PS - 180 model M159D (vii) Cash of Rs 1170 /- (One thousand one hundred seventy rupees only) as per enclosed seizure list duly signed by the Police witnesses as well as accused arrested person along with memo of arrest, this is to report that today at about 17.35 hrs received a reliable source information that online illegal gambling were being held at kamalasthan under PS Adra, Dist-Purulia for huge wrongful monetary gain of some people and wrongful loss to many poor and ordinary people. Accordingly the information is noted in General Diary of Adra PS vide GDE No 421 dtd.11.09.24 at 18.05 hrs and after informing superiors I, SI Shoumik Acharyya of Adra PS, ASI Dulal Singh Sardar, C/620 Maheswar Mondal, C/604 Chandra Sekhar Singh left for Kamalasthan area by Govt. Vehicle having Reg. no -WB 56C - 8995 (vide Adra PS CC No 2341/24 dtd.11.09.24).


At 18.35 we arrived at Kamalasthan under Adra PS. On arrival there as per the source identification, we entered into the room and found that the above noted accused person along with 08(Eight) to 09(Nine) persons are operating online LOTO Lottery were present there in lieu of money. Seeing the police persons the customers, those who were present there left that room and fled away however we could not detained all persons in that room but we successfully detained one noted person. Being asked the person identified himself as Md.Imran (32 Yrs) S/O- Md.Sahid of Vill- Kamalasthan, PS-Adra. Dist-Purulia. On search Cash of Rs-1170/- (One thousand one hundred seventy rupees only) was found on the table in front of accused person. On search apart from the cash the above noted articles(SL No-1 to 6) found present in that room in working condition and being used for the purpose of running such lottery. On demand he failed to produce any license or documents entrusted. So, I seized the above noted articles including cash from the possession of the said detained accused person duly signed by the accompanying Police Forces. As the above noted accused persons committed an offence which is punishable U/S- 3/4 OF WBG& PC Act. I arrested him after observing all formalities of arrest, seizure, search all things completed in between 18:45 hours to 19:15 hours.

Under the above facts and circumstances, I pray that a case under 3/4 of WBG & PC Act May Kindly Started Against Accused(1) Md.Imran (32 Yrs) S/O- Md.Sahid of Vill- Kamalasthan, PS-Adra. Dist-Purulia, and other 07(Seven) to 08(Eight) unknown person along with owner of the place (who fled away from the spot) U/S- 3/4 of W.B.G & PC Act and arrange for its investigation.
