beg to state that I, Maimun Bibi is residing at
Adra, along with my daughter as maid servant. On
6th Aug, 2024 my daughter, Samina Khatun aged 22 yrs
father late Barka Ansari went to Sarbani to
give her B.A (2nd semester) exam. She set out from
home at about 8 a.m. But, that day, she did not
return home. She was wearing yellow kamiz and
yellow salwar. We gave a missing diary to I.C, Thana,
GD NO-232 for this, and also told all my relatives
to locate her but it was of no use.

We all guess that my daughter was kidnapped.
We all are very particular about her and waiting
with heavy heart for her, she was having a mobile
with her whose no is 70 0134 7300. We tried to
contact with her but of no use.

In view of the above circumstances, I
request you to issue order and make arrangements
to find my daughter within no time.

As I am illiterate, so, this letter has
been written by Sanwara Begum, instead of me,
I shall be highly obliged to you.
