Sub :- First Information Report regarding stolen of Laptop, Mobile phone and Cash Rs. 5600/- from Rly Quarter No. DS/342-B, Tagore Colony/Adra in the night of 21/22.09.2024.

Sir,

With profound respect, I, Amit Kumar, Constable/RPF/MIS Cell/Adra beg to state that in the night of 21/22.09.2024 I slept at about 00.30 hrs in my Rly Quarter No. DS/342-B, Tagore Colony/Adra and when I woke up at about 07.15 hrs on 22.09.2024 I found that my front door was in open condition. Then, I immediately searched the room and found my Laptop, Mobile phone and Cash Rs. 5,600/- have been stolen by the unknown outsiders from front room of said Railway quarter.

Sir, it is pertinent to mentioned here that the 02 numbers of SIM card have been ejected from the mobile ejection slot by using ejection pin, the Bluetooth connection has been ejected from Laptop & cash Rs. 5600/- collect from wallet and all the items are kept on the water cooler.

Sir, as a member of the force I basically woke up at about 06.00 hrs daily but today I woke up at about 07.15 hrs. I think the stolen has been done by using spray for unconsciousness to commit such type of offence by the habitual offender.

The following stolen items:-

1. Laptop (Mi Notebook 14 Intel Core i5-10210U 10th generation) Colour Silver, XMA1901-FA. **Amount Rs. 44,038/-**
2. Mobile Phone (XIAOMI 11i) 5G, IMEI No. 869406054461636, 869406054461644. (Without SIM) **Amount Rs. 25,999/-**
3. Cash :- **Rs. 5,600/-**

Total Cost of stolen items: - Rs. 75,637/-
