Sub: FIR against unauthorised use of electricity.

Dear Sir,

I, Goutam Kr. Mandal, S/O- Late Chinta Mani Mandal, Age- 38years, Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Debabrata Kumar (User), S/O- Lt. Haren Kumar of Village -Phasko, PS- Arsha, Dist- Purulia has committed theft of electricity U/S 135(i)(b) of electricity act 2003 subsequently amendment act 2007.

On 24.09.2024 at about 17:05 o'clock I, along with Chandan Mahato, S/O- Lt. Phani Bhusan Mahato, TSH, Arsha CCC and Arpan Podder, S/O- Tapas Podder, OE, Arsha CCC. went to routine inspection in Phasko Village and entered in the premises of Debabrata Kumar (User), S/O- Lt. Haren Kumar of Village -Phasko, PS- Arsha, Dist- Purulia and found that Debabrata Kumar (User), S/O- Lt. Haren Kumar was enjoying electricity unauthorisedly by tampering the installed energy meter by making loop connection with incoming of energy meter, which interferes with proper registering of metering circuit. The loop connection & service line of Debabrata Kumar (User), S/O- Lt. Haren Kumar disconnected on the spot from nearby LTOH Line of WBSEDCL on 24.09.2024. During inspection we found that the service connection is in the name of Haren Kumar father of Debabrata Kumar (User), having Consumer ID- 242178613 and the electrical load he is enjoying as 0.650 KW.

Sri Debabrata Kumar (User) was present on the spot but he is not able to state anything about this illegal act done by him.

The inspection team left the premises of the accused person at about 17:28 o'clock duly signed by the witnesses.

Debabrata Kumar (User), S/O- Lt. Haren Kumar of Village -Phasko, PS- Arsha, Dist- Purulia has committed an offence U/S 135(i) (b) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
