Sub: FIR against unauthorised use of electricity.

Dear Sir.

I Sri Goutam Kr Mandal, S/O Late ChintaMani Mandal, Age-38years, Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Braja Kishor Majhi S/o-Late Manmohan Majhi of Village Satra, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(1)(a) of electricity act 2003 subsequently amendment act 2007.

On 09.09.2024 at about 14.20 o'clock I, along with Sri Alimuddin Ansary, S/o-Lt. Miyazan Ansary, Sr. TSH, Arsha CCC, and Sri Chandan Mahato, S/o-Late Phani Bhusan Mahato, TSH, Arsha CCC, employees of WBSEDCL under Purulia Division went to routine inspection in Satra Village and entered the premises of Braja Kishor Majhi S/o-Late Manmohau Majhi of Village Satra, PS-Arsha, Dist-Purulia, where we have found that accused Braja Kishor Majhi S/o-Late Manmohau Majhi was enjoying electricity by direct hooking unauthorisedly from nearby LTOH of WBSEDCL, for commercial as tailoring and carpentry purpose.

During inspection the accused Braja Kishor Majhi S/o-Late Manmohan Majhi was present home and explain about such unauthorised activity.

Thereafter we have prepared the inspection Report and refused signed by accused person and duly signed by witnesses and disconnected and hooking arrangement from nearby LTOH of WBSEDCL and seized single core single wire (2nos.) pvc copper cable of 20 feet each(approx) with hooking device and one plug arrangement under proper seizure list duly signed by the witnesses.

After completion of our inspection and seizure we have left the premises at about 14.35 o'clock.

Therfore, you are requested to take lawful action the accused Braja Kishor Majhi S/o-Late
Manmohan Majhi of Village Satra, PS-Arsha, Dist-Purulia, for committing offence of theft of electricity U/S
135(i)(a) of the electricity act 2003 with up to date Amendment by treating this written complaint as FIR.
