The above name complainant begs to state as follows:

- 1) That the complainant is the permanent resident of village-Sindri, P.O. G.B. Sindri, P.S. Baghmundi, Dist- Purulia.
- 2) That the complainant is the legally married wife of accused no-1 Hakim Hussain and their marriage was solemnized on 22/02/2024 as per Muslim Shariat in presence of Wakhil, Gawah and Qazi and other persons, and one Nikah Nama i.e. marriage certificate was prepared to that effect.

- 3) That at the time of marriage as per demand of the accused persons, the father of the complainant had to pay a cash of Rs. 1,00,000/- along with Golden and Silver ornaments and other valuable articles, and also another cash of Rs. 1,00,000/- had to pay to the said accused no-1 Hakim Hussain for purchasing Motor Bike.
- 4) That after marriage the complainant went to her matrimonial house at village- Tiruldih, under P.S. Tiruldih, Saraikella Kharswan, Jharkhand and she started her conjugal life as husband and wife with said accused no-1 Hakim Hussain along with the other inmates of the family in the same roof.
- 5) That after 8(eight) days from the date of marriage of the complainant was taken at her paternal house and stayed therein for 5(five) days, thereafter the complainant again went to her matrimonial house and in course thereof not only her husband i.e. the accused no-1, but also the other inmate of the family started all sorts of inhuman, physical as well

mental torture upon the complainant, they also press the neck off and on of the complainant and also disclosed that they will murder her and her body will be placed in a nearby railway line which is very nearer to the house of accused persons. She was driven out from her matrimonial house regularly and spends all those nights in a open verandah.

- 6) That bearing all such torture, the complainant somehow continued her matrimonial life at her matrimonial house for aspect of her good days, but persistent torture upon the complainant was continued till she driven out from her matrimonial house.
- 7) That hearing such torture the parents and other relations of the complainant tried to convince the accused no-1 Hakim Hussain i.e. the husband of the complainant and other inmates of the family and requested them to keep the complainant with proper case and not to torture upon her without any reason and thereafter there was a salish in

presence of villagers and in presence of member of local Gram Panchayat, but the accused no-1 and his inmates in presence of all assaulted the complainant and the above noted persons also gave out that unless Rs. 1,00,000/- be paid to them as additional dowry they will not keep the complainant in their house.

- 8) That when the complainant was at her matrimonial house, on 08/05/2024 in the night she was kept in a room and her husband i.e. accused no-1 and his inmates assaulted the complainant mercilessly and finally they put fire in her wearing apparels, but the complainant somehow put off the fire, but a portion of her apparel were burnt. Unless the complainant be able to put off the fire she will be totally burnt and died. Actually the intention of the accused no-1 and his inmates to kill the complainant by putting fire and the above noted persons actually attempted to cause death of the complainant by fire, but by the grace of God the life of the complainant was saved.

- 9) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- 10) That the matter was reported to the Officer-in-charge Baghmundi P.S. against the accused persons but the said Officer-in-charge did not taken any legal action then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate, then the complainant is under compelling circumstances is filing this complaint before the Ld. Court for appropriate reliefs under the law.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge Baghmundi P.S. for treating the same as FIR under section ^{156(3) G.P.} 175 of B.N.S.S. 2023 for investigation.
