Sub: Written complain to start a cog case against the arrested accused persons.

Sir,

In producing herewith the 02 (Two) arrested accused persons namely 1) Chand Babu (22 Yrs) S/O-Jamir Ansary of Vill-Goura Tand, PS-Mandu, Dist-Ramgarh (JH), 2) Devdhari Munda (22 Yrs) S/O-Sundar Munda of Vill-Baghakudar, PS-Gola, Dist-Ramgrah (JH) along with one seized Truck bearing Reg. No- JH09M/5736 loaded with approx 10 M.T coal, I beg to report that today i.e on 07/09/2024 at about 22:05 hrs received a credible source information that one coal loaded truck bearing Reg. No- JH09M/5736 which has been procured by means of theft, remains stand near a Hotel which is known as Tata Hotel in between Charida and Baghmundi. Accordingly, myself along with force (vide Baghmundi P.S. C.C. No. 3507/24 Dtd: 07.09.24) left P.S. to work out the information after obtain kind permission from O/C Baghmundi P.S. This refers to Baghmundi P.S. GDE No. 367 Dtd: 07/09/2024.

Then, we reached the place as noted above as per source information and found the said truck bearing Reg. No- JH09M/5736 on road (SH-04, Jhalda-Balarampur road) with coal loaded. Accordingly, I asked the driver & KHALASI (assistant of the driver) to produce relevant documents in respect of loaded coal. But they failed to produce any relevant documents though sufficient time was given. So, there was a strong reason to believe that the owner of the above noted Truck, Driver & KHALASI procured the coal by means of theft or any fraudulent means and were transporting the same for some wrongful gain.

Being asked, they disclosed their identity as Chand Babu (22 Yrs) S/O-Jamir Ansary of Vill-Goura Tand, PS-Mandu, Dist-Ramgarh (JH) who is the driver of the truck bearing Regd. No- JH09M/5736 and Devdhari Munda (22 Yrs) S/O-Sundar Munda of Vill-Baghakudar, PS-Gola, Dist-Ramgrah (JH) who is the KHALASI of the truck bearing Regd. No- JH09M/5736.

As such, I seized the said Truck bearing Regd. No- JH09M/5736 as well as the said loaded Coal approx 10 M.T. with proper seizure list duly signed by the witnesses. No public was ready to put their signature on any paper to avoid police indulgence. The entire process has been recorded by audio-video means. I also arrested the above noted accused persons after prepared proper memo of arrest & issued one copy to them. During arrest, they were well informed regarding cause of arrest.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons and owner of the Truck bearing Reg. No. JH09M/5736 as per proper section of law.
