**Sub: Lodging F.I.R against Sri Dhapan Sahis, S/o. Lt. Jahar Sahis for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).**

Sir,

I Sri Sisir Kumar Das, S/O- Banamali Das, D.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sri Dhapan Sahis, S/o. Lt. Jahar Sahis resides at Vill-Hanspur, P.O:- Salboni, PS: Balarampur, Dist. Purulia to the effect that received an information, that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information on 11.09.2024 from 04:55 PM to 05:20 PM I, along with Sri Manab Kr. Maji, J.E.(E) Gr-II, Sri Arindam Chatterjee, Sr. O.E of Balarampur CCC and technical persons of M/s. Ajay Kumar Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Dhapan Sahis and held raid.

During raid and inspection it was detected that accused Dhapan Sahis is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 2 nos. 100 watt Bulb, 2 Nos Ceiling Fan, 1 no. TV having connected load is 0.38 KW.

I prepared inspection report in presence of the Accused and assessed the Load as 0.38 KW. Details have been mentioned in the Inspection Report duly L.T.I of the accused.

I directed Sri Rajib Sahis, Supervisor of M/s. Ajay Kumar Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line/ arrangement from our LTOH line. Accordingly they disconnected the aforesaid hooking line/arrangement from LTOH Line.

I prepared seizure list in presence of the accused & witnesses, details of seizure have been mentioned in the seizure list and took the L.T.I of the accused person on it. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the abovementioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
