Complaint against Lalmohan Mahato (35 yrs approx) S/O- Gopal Mahato of Vill- Supurdih, P.S-Sub:-Balarampur, Dist. Purulia under proper section of law.

Respected Sir, In producing here with one arrested accused person Lalmohan Mahato (35 yrs approx) S/O-Gopal Mahato of Vill- Supurdih, P.S- Balarampur, Dist. Purulia along with seized approx 08 (eight) litres ID liquor in a white plastic jarican (smell), 10 pieces of plastic glass, one white polythine chat, (details of seized articles are mentioned in attached seizure list), to the effect that today i.e. on 21.09.2024, I ASI Anirban Banerjee of Balarampur PS along with C/2423 Siddeswar Gorai & C/3301 Md. Mannan Ansary both of Balarampur PS, Purulia was engaged in Dava Evening Mobile duty vide Balarampur PS CC No- 3424/2024 dt-21.09.2024. In course of Dava Evening Mobile duty at about 19:05 hrs. I have received an information from a reliable source that one person has stored some illicit liquor at the house of Lalmohan Mahato at village Supurdih under Balarampur P.S & selling the same to innocent people for his personal gain. Accordingly, I informed to O/C Balarampur P.S. regarding this matter and as per his direction I along with force left for Supurdih to work out this information. At about 19:45 hrs I along with force reached at Supurdih village and contacted with my source. From a reasonable distance my source has identified the place where the ID liquor has stored illegally. I along with force held raid and found that one person is selling ID liquor which is stored in a plastic jarican. On seeing the Police party the person tried to flew but I along with force apprehend the person. On asking the apprehended person disclosed his name as Lalmohan Mahato (35 yrs approx) S/O- Gopal Mahato of Vill-Supurdih, P.S- Balarampur, Dist. Purulia. On interrogation he confessed that he was selling the ID liquor in lieu of money for his personnel gain. On demand he failed to produce any valid documents / challan or License in respect of ID liquor.

Accordingly, I seized 08 litters approx ID liquor in a white plastic jarican (smell), 10 pieces plastic glasses, one white polythine chat from the possession of accused person after preparing proper seizure list duly signed by the witnesses and the accused person. I also took 500 ML ID liquor as sample in a plastic bottle from the mother container and sealed & labelled all the articles on the spot. The seizure procedure was done in between 20:25 hrs to 20:45 hrs. and arrested accused person namely Lalmohan Mahato (35 yrs approx) S/O- Gopal Mahato of Vill- Supurdih, P.S- Balarampur, Dist. Purulia after preparing proper arrest memo after maintaining all the formalities as per NHRC

Under the above circumstances, I therefore pray that a specific case may kindly be started against the arrested accused person Lalmohan Mahato (35 yrs approx) S/O- Gopal Mahato of Vill-Supurdih, P.S- Balarampur, Dist.
