I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Mamata Karmakar, W/o – Late Charan Karmakar resident of Vill- Dhabani, PO - Sagasupururi, PS – Bundwan, Dist – Purulia has committed theft of electricity u/s 135/1/a of The Electricity Act, subsequently Electricity (Amendment) Act 2007.

On 12/09/2024 about 14:10 Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Subhankar Majumdar, Sr. TSH, Bundwan CCC, WBSEDCL and Raghunath Soren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Mamata Karmakar at Vill- Dhabani, PO - Sagasupururi, PS – Bundwan, Dist – Purulia and inspect her premises. During inspection it was found that she was using electricity in her house dishonestly by means of Direct Hooking from nearest pole and was distributing electricity to Swarna Karmakar (Meter No. B4214879) whose connection was previously disconnected due to nonpayment of electricity bill.

From the above arrangement they were using the following electrical equipment's:

- 1) FAN – 2 Nos, 2) Bulb – 4 Nos

Out of which I seized the following:

- 1) PVC Black color service cable of approx. 6 Mtr approx.

Seizure list was prepared at the site and accused person has signed.

The inspection team left the premises at 14:40 Hrs on 12/09/2024.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
