I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Ghaltu Mahato, S/o – Jogendra Mahato resident of Vill- Roladih, PO - Gangamanna, PS – Bundwan, Dist – Purulia has committed theft of electricity u/s 135/1/a of The Electricity Act, subsequently Electricity (Amendment) Act 2007.

On 12/09/2024 about 14:58 Hrs. I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Subhankar Majumdar, Sr. TSH, Bundwan CCC, WBSEDCL and Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Ghaltu Mahato at Vill- Roladih, PO - Gangamanna, PS – Bundwan, Dist – Purulia and inspect his premises. During inspection it was found that he was using electricity in his house dishonestly by means of Direct Hooking from nearest pole.

From the above arrangement he was using the following electrical equipment's:

- 1) FAN – 1 Nos, 2) Bulb – 3 Nos 3) Laptop 4) Refrigerator – 1 Nos

Out of which I seized the following:

- 1) PVC Black color service cable of approx. 8 Mtr approx.

The inspection team left the premises at 15:25 Hrs on 12/09/2024.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.
