Sir,

I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that against 1) Bhairab Mahato 2) Mansaram Mahato 3) Shibu Mahato son of Late Bharat Mahato resident of Vill- Liki, PO - Jitan, PS – Bundwan, Dist – Purulia has committed theft of electricity u/s 135/1/a of The Electricity Act, subsequently Electricity (Amendment) Act 2007.

On 13/09/2024 about 12:10 Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL along with, Shubhankar Majumdar, Sr. TSH, Bundwan CCC, WBSEDCL and Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Late Bharat Mahato at Vill- Liki, PO - Jitan, PS – Bundwan, Dist – Purulia and inspect his premises. During inspection it was found that sons of Late Bharat Mahato, 1) Bhairab Mahato 2) Mansaram Mahato 3) Shibu Mahato were using electricity in that house dishonestly by means of Tapping of Service Wire before the energy Meter [bearing SI No. GS007050].

From the above arrangement they were using the following electrical equipment's:

1) FAN – 3 Nos 2) Light – 5 Nos 3) Cooler – 2 Nos 4) Refrigerator – 1 Nos 5) Mixer – 1 Nos

Out of which I seized the following:

1) PVC Black color service cable with tapping portion of approx. 8 Mtr approx.

The seizure list was prepared at the site and the representative of the accused signed it.

The inspection team left the premises at 12:45 Hrs on 13/09/2024.

The accused person(s) has committed an offence under section 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
