I Sri Gotirmoy Dass, S/O – Lt Lachhman Dass, Station Manager of Chakda CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Kartik Kumar S/O S/o- Leru Kumar of Vill - Bazra PS- Barabazar has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 11.09.2024 I, Gotirmoy Dass (SM), along with Sri Indrajit Sinha JE (GR-I), & Sri Shyamapada Mahato (Sr TSH) of Chakda CCC, WBSEDCL conducted a raid programme at village Bazra under Barabazar P.S. When our team at about 02.10 pm, entered to the Domestic premises of Kartik Kumar, we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LT OH Line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.20 pm, after completion of inspection & necessary formalities.

Kartik Kumar S/O S/o- Leru Kumar of Vill - Bazra, PS- Barabazar has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
