I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that MD. ALIMUL HUSSAIN, S/O LT MD. ANWARUL HUSSAIN VILL – SINDRI, Dist- Purulia was enjoying electricity illegally by connecting the outgoing wire of the energy meter to the incoming terminal of the energy meter directly by-passing the Single Phase Energy Meter (SI No- L4137761) and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).
