This is to inform you by undersigned that during inspection of LT network unauthorised use of electricity was found. Therefore, I, the undersigned do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Bidhubhusan Murmu, S/o-Rajaram Murmu, Vill-Jhariadih, PO- Kutni, PS- Boro, Dist- Purulia-723131, has committed unauthorised use of Electricity U/s 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 03.09.2024, at about 12:05pm, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with Sri Somenath Laha, H.G.Sr.L.M, Manbazar CCC WBSEDCL, Sri Sourav Mukherjee, Sr, T.S.H, Manbazar CCC & Sri Gopinath Mahato, Senior TSH, Manbazar CCC, WBSEDCL entered the premise of Bidhubhusan Murmu, S/o-Rajaram Murmu, Vill- Jhariadih, PO- Kutni, PS- Boro, Dist-Purulia, and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from nearest LTOH line of WBSEDCL.

During inspection, it was found that he was using electricity dishonestly U/s 135(1)(a) was detected. It was found that he was using the following electrical

- 1)Three nos incandescent lamp of 100 watt each
- 2)Three nos ceiling fan of 60 watt each
- 3)Two nos LED bulb 09 watt each

Out Of which 06 (six) meters flexible copper wire (Red & Yellow coloured) with a 09 watt LED lamp with a lamp holder along with hooking device is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 12:20 pm on dated 03.09.2024. The accused person has committed an offence U/s 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
