I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Dhananjoy Sing, S/o – Santosh Sing, resident of Vill- Telighana, PO - Jamtoria, PS – Boro, Dist – Purulia has committed theft of electricity U/S 135/1/a and misplaced of electric Meter bearing sl no. T1989791 u/s 135/1/c of The Electricity Act respectively.

On 03/09/2024 about 13:20 Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Subhankar Majumdar, Sr. TSH, Bundwan CCC, WBSEDCL and Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Dhananjoy Sing, S/o – Santosh Sing, resident of Vill- Telighana, PO - Jamtoria, PS – Boro, Dist – Purulia and inspect his premises. During inspection it was found that he was using electricity dishonestly by means of Direct Hooking from nearest LTOH line after misplace/removal of electric meter Sl. No. T1989791.

From the above arrangement he was using the following electrical equipment's:

- 1) FAN – 3 Nos, 2) Bulb – 6 Nos, 3) TV – 1 Nos

Out of which I seized the following:

- 1) PVC Black color service cable of approx. 15 Mtr approx.

The inspection team left the premises at 14:05 Hrs on 03/09/2024.

The accused person has committed an offence U/S 135/1/a and 135/1/c of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.
