I, the undersigned do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Binod Mahali, S/O- Prahlad Mahali, Vill- Malian, PO- Bari, PS- Boro, Dist - Purulia-723131, has committed unauthorised use of Electricity U/s 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 05.09.2024, at about 01:05 pm, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with Sri Asit Baran Kundu, J.E(E) Gr-II, Manbazar CCC, WBSEDCL, Sri Soumik Chatterjee, Senior O.E, Manbazar CCC, WBSEDCL, Sri Sourav Mukherjee, Sr, T.S.H, Manbazar CCC, WBSEDCL entered the premise of Binod Mahali, S/O-Prahlad Mahali, Vill- Malian, PO- Bari, PS- Boro, Dist - Purulia, and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from nearest LTOH line of WBSEDCL.

During inspection, it was found that he was using electricity dishonestly U/s 135(1)(a) was detected. It was found that he was using the following electrical equipments-

- 1)One no incandescent lamp of 100 watt
- 2)One no incandescent lamp of 60 watt
- 3) One no table fan of 145 watt

Out of which about 05 (five) meters flexible copper wire with a 100 watt incandescent lamp with a lamp holder along with hooking device is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 01:20pm on dated 05.09.2024. The accused person has committed an offence U/s 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
