Respected Sir/Madam,

I, Raju Sen S/O Sahadev Sen, 12 KapasaraChirkunda Near Kapasara School Nirsa-Cum-ChirkundaChirkunda Dhanbad Jharkhand - 828202serving as the AGM - Marketing at Maithan Steel & Power Ltd. (hereinafter referred to as the "Complainant Company"), with its registered office at [Insert Address], West Bengal, hereby lodge this formal complaint for your immediate action and investigation.

The Complainant Company, Maithan Steel & Power Ltd. (MSPL), is the authorized manufacturer and seller of JINDAL MARK TMT BAR products in West Bengal, as per a legally binding agreement dated [Insert Date] with Jindal Rolling Mill. Under this agreement, MSPL holds the exclusive rights to manufacture, market, and sell JINDAL MARK TMT BAR products in the state. The JINDAL MARK TMT BAR is a registered trademark, and MSPL is the sole proprietor of all associated intellectual property rights in the region.

It has come to our attention that **Ganesh Traders Prop: Jaganath Dutta of Place Hura W.B. 723130** in the local markets of West Bengal are unlawfully engaging in the manufacturing and sale of counterfeit JINDAL MARK TMT BAR products. These counterfeit products are being falsely presented as genuine JINDAL MARK TMT BAR, thereby deceiving consumers and infringing upon the exclusive rights held by the Complainant Company.

These unauthorized activities constitute serious criminal offenses, including Cheating and Deception. The offenders are deliberately misrepresenting counterfeit products as genuine



JINDAL MARK TMT BAR, causing significant harm to consumers and the Complainant Company.

By selling counterfeit products under the Complainant Company's brand, the offenders are breaching the trust that consumers place in our brand and violating the exclusive rights granted to the Complainant Company.

The manufacture and sale of these counterfeit products involve the illegal use of the Complainant Company's registered trademark, constituting Forgery and Trademark Infringement and forgery under the relevant provisions of the law.

The unauthorized use of the Complainant Company's intellectual property and branding without consent further exacerbates the legal violations and infringement of copyright.

These unlawful actions are not only tarnishing the reputation and goodwill of the Complainant Company but also inflicting significant financial losses on both the company and the state government of West Bengal due to reduced revenue and tax losses.

In light of the above, I urgently request you to take immediate action against **Ganesh Traders Prop: Jaganath Dutta of Place Hura W.B. 723130** to Investigate the matter, Identify and apprehend the individuals and firms involved in these illegal activities to cheating, criminal breach of trust, and trademark infringement.

Take necessary steps to prevent the continued sale and distribution of counterfeit JINDAL MARK TMT BAR products in the market.

Given the gravity of this issue, I therefore request you treat this complaint as an First Information Report and take necessary action as per the law of land
