Sir,
In producing here with one arrested accused person namely Kalipada Majhi (55 yrs) S/O- Lt. Jhari Majhi of Vill- Karandih, P.S.-Hura Dist-Purulia, along with following seized articles.

1) One Yellow colour plastic container with approx 5 ltrs. of ID liquor (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Bangshi Badan Mandal of Hura PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 13.09.2024 at about 19.05 hrs. during my Spl. mobile duty at PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his house at Karandih village. On receiving the reliable source information I communicated with O/C Hura PS over telephone and as per his instruction I along with i) ASI Kritibas Mahato and ii) HG/1441 Sukumar Kalindi both of Hura PS, rushed in the house of Kalipada Majhi (55 yrs) S/O- Lt. Jhari Majhi of Vill- Karandih, P.S.-Hura Dist-Purulia to work out the information vide Hura PS GDE No. 609 & CC No. 2027 Dtd. 13.09.2024. Reaching at Karandih village at about 19.35 hrs we fixed-up in the house of above noted accd. person Kalipada Majhi (55 yrs) S/O- Lt. Jhari Majhi of Vill- Karandih, P.S.-Hura Dist-Purulia and found that selling of Id Liquor was going in his house and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. It took time from 19.45 hrs. to 19.55 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 20.05 hrs after observing all the formalities issuing memo of arrest.

I therefore pray that a specific case may kindly be started against the accused Kalipada Majhi (55 yrs) S/O- Lt. Jhari Majhi of Vill- Karandih, P.S.-Hura Dist-Purulia under proper section of law.
