Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Kajal Bauri , S/O- Haren Bauri was enjoying electricity unauthorisedly i.e. by means of direct hooking from the nearest pole of WBSEDCL and due to this reason he had committed theft of electricity u/s 135 (1)(a) of the Electricity (Amendment Act-2007).

On 20.09.2024 at 03:30 pm I, Achintya Mahata, DE & Station Manager Hura CCC, WBSEDCL, along with Sri Partha Chakraborty, DE (S&LP), Purulia Regional Office, WBSEDCL, Sri Promod Ranjan Barman, SO, S& LP unit Purulia Regional Office, WBSEDCL, Sri Dayamay Mahato, Sr. TSH, S&LP, Purulia Regional Office, WBSEDCL and Sri Biswajit Pal, JE(Gr-II), Hura CCC, WBSEDCL, entered the premises of Kajal Bauri , S/O- Haren Bauri at Bhagabandh, Chakalta Hura, Purulia and inspected his premises. During inspection, theft of electricity was detected i.e. he was using electricity dishonestly by means of direct hooking from the nearest pole of WBSEDCL i.e. u/s 135 (1)(a) was detected.

From the above arrangement, he was using the following electrical equipments:

- 1) Electric Motor-01 no
- 2) Electric Cutter-01 no

Out of which, I seized the following electrical items:

- 1) Single core 2 wire copper PVC cable of approx 16 ft fitted with 3 pin plug socket and with hooking device.

Seizure list was prepared at the site, the accused person signed. After that the inspection team left the premises at 03:45 pm on 20.09.2024. The accused person has committed an offence u/s 135 (1)(a) of the Electricity Act-2003 (Amendment Act-2007).

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
