The humble submission on behalf of the complainant/
your petitioner, Most respectfully beg to state :

- 1) That your petitioner, witnesses, acc used persons are the residents under Jhalda Police Station which is under your Jurisdiction.
- 2) That on 7:30 (Approx) ~~am~~ a.m. of 09/05/2024 while the aged old father of your petitioner was staying alone at our house, all the accused persons entered in the house of your petitioner with spade, Sabal (thick Iron Rod) Axe etc. and started demolish a newly constructed Pucca wall on the east side of the house.
- 3) That the aged, weak father of your petitioner being Panic- stricken, silently took shelter in a corner of the house to save him from the violent accused persons.
- 4) That after a while of there such a illegal forceful activities they entered into the room and brok open a Box kept inside and took Rs. 1,94,449/- (Rupees one lake ninety four thousand four hundred forty nine) the amount was collected by selling paddy and the whole money was kept in the Box as the family members of your petitioner used to keep there money in that Box which was~~x~~ locked.

- 5) That after completing theft by looting the amount they noticed the frightened father of your petitioner, and they threatened and warned him to remain silent about stealing of money and breaking of wall by them, and they declared that if he tells anybody about this they will murder him alongwith other family members of your petitioner.
- 6) That after sometime, the complainant and others reached house and learned the facts from his father, who was still afraid of them, your petitioner at about 7:50 A.M. started taking photos of the broken wall as well as broken Box, all the accused person again enter the house of the complainant/ petitioner and they attacked your petitioner and started beating him mercilessly, one of the accused Rajesh Paramanik @ Malu seated on my chest and beating your petitioner and pressed my throat to kill your petitioner some how your petitioner enlarged him, they left the place by giving everybody of the family of your petitioner with dire-consequence if they disclose the matter.
- 7) That to avoid the accused persons, they watching the each members of the petitioner, your petitioner send the F.I.R. / complaint to the Inspector in-charge by registered post on 14/05/2024.

- 9) That all the accused person with a joint intention of making theft and breaking the wall committed the offence punishable under appropriate sections.

In these situation, it is therefore prayed that your Honour may be graciously to send this petition to the I.C., Jhalda, Police Station to treat this petition as F.I.R. as contemplated U/s. ~~175~~ ^{156 Cr. P.C.} and to register a case against the accused person to enable them to trial in open court.
