I, SI Goutam Kr. Bangal along with force returned to PS with 02 (two) arrested accd. persons namely (i) Surya Mudi (38) S/O Ramasis Mudi of Vill- Narayanpur, PO-Sindri, Chasroad, PS-Joypur, Dist-Purulia (ii) Anubhav Choudhury (22) S/O Janardhan Choudhury of Vill- Kotshila, PS-Kotshila, Dist-Purulia along with seized article i.e. (i) one master key which is used to unlock any kind of house lock (ii) one saving blade (iii) one small size screw driver (iv) one set Ear ring like gold (v) one baby Tyra like silver (vi) one set baby hand Tabiz like silver under proper seizure list using Audio and videography of the enter process and produced before your good self.

The fact in brief is that today (13/09/2024) myself along with force namely C/682 Mahadeb Rajak, NVF/778 Samir Mahato were performing anticrime mobile duty in PS area vide Jhalda P.S. GDE No- 619/24 Dated-13/09/2024. During my said duty, at about 19:45 hrs, received a source information that the above noted arrested accused persons have been coming from Kotshila side using the Jhalda Purulia SH-4A Road towards Jhalda Bazar. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No 625/24 dated 13/09/2024. Consequently, as per your kind order I started Naka at near New SDO Office under Jhalda PS no entry point by placing the guardrail on the said road. Thereafter I notice that the 01 (one) Toto was proceeding towards Jhalda Bazar. Consequently, we intercepted the said Toto at Naka checking point at about 21:45 hrs and found that the said Toto as well as the above noted accused persons as identical as I received prior information. But seeing the Police Party the accused persons who were on that Toto tried to flee away. After hot chase we managed to apprehend them. On being asked, they did not disclosed their identity and also for their suspected activities I searched them thoroughly and found that few suspected articles (i) one master key which is used to unlock any kind of house lock (ii) one saving blade (iii) one small size screw driver (iv) one set Ear ring like gold (v) one baby Tyra like silver (vi) one set baby hand Tabiz like silver from their exclusive possession. During interrogation they did not given any satisfactory answer about the matter and they did not produced any kind of valid documents in respect of these suspected articles. So, I seized the said suspected articles after preparing proper seizure list in presence of available witnesses and also made proper Audio and Videography of the enter processed as well as duly signed by the witnesses. Thereafter, 1 arrested the accused persons namely (i) Surya Mudi (38) S/O Ramasis Mudi of Vill-Narayanpur, PO-Sindri, Chasroad, PS-Joypur, Dist-Purulia (ii) Anubhav Choudhury (22) S/O Janardhan Choudhury of Vill- Kotshila, PS-Kotshila, Dist-Purulia after disclising the ground of their arrest and issued Memo of Arrest against them. Thereafter, I brought them to PS as well as the said seized articles.

Under the above facts and circumstances kindly take lawful action against the arrested accused persons namely (i) Surya Mudi (38) S/O Ramasis Mudi of Vill- Narayanpur, PO-Sindri, Chasroad, PS-Joypur, Dist-Purulia (ii) Anubhav Choudhury (22) S/O Janardhan Choudhury of Vill- Kotshila, PS-Kotshila, Dist-Purulia as they committed offence U/S- 303(2)/317(2) BNS.
