Sir,

In producing herewith one arrested accused person namely Bhajahari Bagti (51 yrs) S/O-
Late Nakul Bagti of Vill-Khedatard PS-Joypur, Dist-Purulia along with seized articles as per seizer
list i.e. (i) 22 (Twenty-two) bottles country spirit styled as "Dil Khus" measuring 600 ml each.

I, SI Joydev Gorai of Joypur PS hereby lodged a written typed complaint against the above
noted arrested accused person to the effect that on today 13/09/2024 when myself along with force (1)
C/-681 Notan Ch dey (2) C/-1177 Samir Das, were performed special duty under Joypur PS area
vide Joypur PS CC No-2809/24 Date-13/09/2024, as per my source information I reached at Joypur
Forest Check Post in the shop of Bhajahari Bagti under Joypur PS and found that the above noted
accused person selling country spirit in his shop. On seeing Police party, the customers fled away
from the spot but somehow, we manage to detain the above noted accused person. On being searched
we found 22 (Twenty-two) bottles country spirit styled as "Dil Khus" measuring 600 ml each, from
his possession. On being asked he disclosed his name and address as noted above. On interrogation
he stated that he was selling country spirit to the local people in the area. On demand he failed to
produce any valid documents in respect of selling such country spirit. So, it is reasonable to believe
that he was selling the country spirit illegally without any documents. So, I seized the same under
proper seizure list with **videography** in between 20.45 hrs to 20.55 hrs & label duly signed by him
and other available witness after taking 01 (one) bottle country spirit measuring 600 ml of each brand
as sample.

During further interrogation he confessed his guilt as such I arrested him today 13/09/2024 at
21:05 hrs after maintaining all formalities as per guide line of Ld. Appex Court / WBHRC/NHRC as
the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely
Bhajahari Bagti (51 yrs) S/O- Late Nakul Bagti of Vill-Khedatard PS-Joypur, Dist-Purulia U/S-46A
(c) of the Bengal Excise Act 1909.
