I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity U/S-135(1)(E) Electricity amendment Act-2007 to the effect that Sri SK SAJAD, S/O-SK Samsul, near garage, Village - Gourandihi, Kashipur, Dist. - Purulia was enjoying electricity by means of unauthorized extension of load from other meter with same premises and suppressing of the fact of the deemed meter OSD amount.

During the inspection it was found that the consumer (actual user) was consuming electricity through meter no. BE0493498 dishonestly without clearing of the OSD amount of Deemed meter with consumer ID 242310737 and meter no. P210280
