I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity U/S-135(1)(b) Electricity amendment Act-2007 to the effect that Actual user iro Sri Manik Ruhidas S/o- Late Amulya Ruhidas of Vill-Gopalpur Indrabil PS-kashipur, Dist. - Purulia (having electrical connection with meter no. H513133 against consumer ID 242065940), has committed theft by means of bypassing of electrical energy meter.

On dated 02.09.2024 at 10.55 A.m, undersign along with

- 2) Sri Uttam kumar Mahatha, Sr TSH, Kashipur CCC, WBSEDCL

Entered the premises of Sri Manik Ruhidas S/o- Late Amulya Ruhidas of Vill-Gopalpur Indrabil PS-kashipur, Dist. - Purulia (having electrical connection with meter no. BB0514319 against consumer ID 242276923). During the inspection it was , i.e. he was consuming electricity dishonestly by means of bypassing of electrical energy meter through 1 sq. mm cable 1 mtr approx.

From the above inspection it was found that he was consuming load of Total 500 watt

Out of which the following item has been seized:

- 1) Meter no. BB0514319, Bentec Bhartiya Enginners PVT Ltd with intentionally damage incoming service cable of approx. 2 core, 6 sq. mm.
- 2) 1 mtr damaged incoming 1 sq.mm 1 mtr approx green colour and intentionally the consumer damage incoming service cable and consuming load of 500 Kw

Seizer list is prepared at the site and accused person refused to sign the list

The inspection team left the premises at 11:10 A.m on dated 02.09.2024. the accused person has committed an offence U/S- 135(1)(b) of the electricity amendment Act - 2007
