I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity U/S-135(1)(b) Electricity amendment Act-2007 to the effect that Actual user iro Sri Ayodhyapati Mahato S/o- Late Bibhutibhusan Mahato of Vill-Pabrapahari, PS-kashipur, Dist. - Purulia (having electrical connection with meter no. L4626966 against consumer ID 242063596), has committed theft by means of bypassing of electrical energy meter.

Entered the premises of Sri Ayodhyapati Mahato S/o- Late Bibhutibhusan Mahato of Vill-Pabrapahari, PS-kashipur, Dist. - Purulia (having electrical connection with meter no. L4626966 against consumer ID 242063596). During the inspection it was, i.e. he was consuming electricity dishonestly by means of bypassing of electrical energy meter.

From the above inspection it was found that he was consuming load of **Total 2.25 KW.**

Out of which the following item has been seized:

- 1) Meter no. L4626966, Lendis Gyer with intentionally damage incoming service cable of approx. 2 core, 4 sq. mm.
