Sub:- Prayer for lodging a F.I.R against accd. Astik Ch. Sahis (38 yrs) S/o- Lt. Durjadhan Sahis, of vill- Konapara, PS-Kenda. Dist. Purulia.

Respected Sir,

In producing herewith the arrested accused person namely Astik Ch. Sahis (38y) S/o- Lt. Durjadhan Sahis, of vill- Konapara, PS- Kenda. Dist. Purulia with seized articles Four plastic Jariken each containing approx 10 ltrs. of ID liquor (Mahula) (Total approx 40 ltrs) having strong smell of I.D liquor(Mahula)and approx about 375 ML of I.D liquor(Mahula) as sample from in each seized jariken under proper seizure list as label. I beg to report that today i.e. on 22.09.2024 evening while myself along with force namely 1. C/399 Kartick Sing Mura, 2. HG - 1923 Banamali Manki was engaged in evening mobile duty in P.S area vide Kenda PS CC No 1510/24 Dated 22.09.2024. At about 20.30 hrs, received a secret source information that the person namely Astik Ch. Sahis (38 yrs) S/o- Lt. Durjadhan Sahis, of vill- Konapara, PS- Kenda. Dist. Purulia is selling I.D liquor(Mahula) at Konapara Jungle illegally. To work out the secret source information, I informed the matter to O/C Kenda PS immediately over phone and as per his verbal direction, myself along with force rushed to that spot and met with my source there. As guided by my source, keeping our vehicle in a certain distance, I along with force in proper police uniform quickly moved towards the place where I found some persons assembled in Konapara Jungle. On seeing us in police uniform, the said persons who assembled there, started to flee away. Accordingly, I along with my force held raid and was able to apprehend the above accused person from the spot. On interrogation, he disclosed his identity as noted above and also confessed that he sells I.D liquor(Mahula) at the Konapara Jungle since long without any legal permission. I verbally offered him for our search, but he refused. Thereafter, I searched the Jungle with proper videography and found four plastic jariken kept in Konapara Jungle loaded approx 40 (Forty)ltrs of ID liquor(Mahula). On being asked he could not produce any license or valid document in respect of the said ID liquor(Mahula) or his business. I also asked him to disclose the identity of the person who could manage to flee away from the spot. However, he did not disclose any ones name and stated that they were their customers whose names are not known to him. I also tried to collect their names from the local people who gathered on the spot, but none could tell anything. Under these circumstances, it was clear that the above named accused person is selling liquors from the Jungle to the person who fled away & stocking liquors with a view to wrongful gain to them. Accordingly, I collected the 375 M.L ID Liquor (Mahula) from seized each Four Jarikens as sample under proper seizure list duly signed by the witnesses in between 20.45 hrs to 21.25 hrs also prepared its label. On asked no one came forward to sign in the seizure list as seizure witness so finding no other alternative, I took signature of my accompanying force as seizure witness. After reading it over to the accused person in his own language, I obtained his signature on the seizure list and label and also supplied a copy to him. Thereafter I issued him notice U/S 35(3) BNSS but he deny to received it, finding no other alternative I arrested him U/S 46A(C) BE Act 1909. During arrest I followed all the guide lines of Ld Apex Court. NHRC & WBHRC and the ground of arrest was duly notified and informed has relative issued arrest memo and handed a copy of the same to arrestee Seized articles.

Under the above fact and circumstances, I pray before your kind self that a specific case may kindly be registered against the above noted arrested accused person under proper section of law and arrange for its investigation.
