Dear Sir,

This is to inform you by undersigned that during inspection of LT network unauthorised use of electricity was found. Therefore, I, the undersigned do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Kamal Mahali, S/O-Budheswar Mahali, Vill- Mahalidih, PS- Kenda, Dist- Purulia, has committed unauthorised use of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 04.09.2024, at about 11:00 am, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with Sri Santu Dhali, JE GR II, Manbazar CCC, Sri Soumik Chatterjee, SR. O.E., Manbazar CCC and Sri Somenath Laha, H.G.Sr.L.M, Manbazar CCC WBSEDCL entered the premise of , Kamal Mahali, S/O- Budheswar Mahali, Vill- Mahalidih, PS- Kenda, Dist- Purulia and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from nearest LTOH line of WBSEDCL.

During inspection, it was found that he was using electricity dishonestly U/S 135(1)(a) was detected. It was found that he was using the following electrical equipments-

- 1) Four nos incandescent lamp of 100 watt each
- 2) Three nos fan of 60 watt each
- 3) One nos TV of 60 watt

Out Of which 10 (ten) meters PVC wire along with hooking device is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 11:15 am on dated 04.09.2024. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
