Most respectfully beg to state as follows :-

- 1) That both the parties are the residents of P.S. Kotshila which is under your Jurisdiction.
- 2) That the petitioner was married with the accused no.-1 on 01/06/2010^h as per Muslim Act, customs as prevalent to their societies in presence of all the relatives of both the parties.
- 3) That after marriage your petitioner started living with her husband peacefully in her matrimonial house for some days.
- 4) That the husband of your petitioner accused No.-1 used to take contract of Pandels in the various occasion at TATA, Jharkhand Area.
- 5) That for the requirement of capital in his such business the father of your petitioner gave him Rs. 42,000/- in cash on the day of their marriage some Gold ornaments, furnitures were also given to the members of the accused person -1 as per their demands.
- 6) That after six months of their marriage all the accused persons, including the husband started committing tortures,

both physically and mentally upon your petitioner and started ~~giving your petitioner~~ started giving orders to your petitioner to bring more money for the development of ~~the~~ their pandal- decoration business within Tata, Jharkhand, Parents were poor ~~was~~ and were unable to meet their demand and as a result your petitioner had to bear tortures.

7) That the husband, i.e. accused No.-1 being a habitual drinker, drug-addicted used to hit your petitioner as and when in Drunken state, used to neglect your petitioner by not giving proper care, proper food dress even not giving any little cosmetic also. Her life was like a hell.

8) That in the mean time, your petitioner received an information from a reliable source they the accused husband again married an another girl.

9) That with this matter and regular ispeace and physical tortures your petitioner was very much disturbed and at this stage of mental position all the accused persons again on 33/06/2011 ordered her at once to bring more money from her mother, as her father died before some day, she was th carrying seven months womb but the ~~was~~ cruel person did not consider it.

10) That your petitioner declare that she was not able to go to her mother for bringing more money, than all the

violent accused persons started beating her and they pushed by neck and driver out from their home on 23/06/2011. ✓

11) That being driven out from her matrimonial house your petitioner started living with her mother from 23/06/2011 and in the course of time she gave birth of a male child, whose present age is 12 years, being named as Daud Ibrahim Ansary. ✓

12) That on 03/06/2024 your petitioner lodged a F.I.R. before the I.C. Kotshila, but they did not take any legal steps.

13) That being compel, your petitioner filed a complaint before the Hon'ble S.P. Purulia on 23/06/2024 but to no effect

14) That all the accused persons jointly tortured your petitioner very rudely made 2nd marriage and as such they have committed offence punishable under appropriate section of law

It is therefore prayed that your Honour may please send this petition to the I.C., kotshila Police station giving direction to treat this petition as F.I.R. as contemplated U/s. ^{156 Cr. P.C.} ~~475~~ of ~~Cr.P.C.~~ and to register a criminal case against the accused person to enable them to face trial in open court.
