January, 2024.

The humble Petition on behalf of
the Complainant ;

state as follows :-

That, your Complainant/informant is the legally
wife of the accused Mahabir Kumar S/o. Late Bhela
whose marriage was held on 22/04/2022 at Kumardih, P.S.-
Dist.- Purulia, as per Hindu Law and Customs.

That, at the time of marriage the father of the
Complainant was compelled to give Rs. 70,000/- (Rupees Seventy

and) as dowry money to the accused No.1 and other
things namely golden ear rings, one golden chain with
brooch, one golden ring, Almirah, dressing table and other
articles to the accused persons.

That, after marriage both the Parties began to
reside at Chakia, P.S.- Ketshila i.e. the house of the
accused persons as husband and wife.

That, since after marriage the husband and his
sister Bharati Kumar put pressure upon your complainant to
give Rs. 1,00,000/- (Rupees One Lakh) more otherwise she
will not be allowed to stay there and the mother-in-law
isolated your complainant from the husband and not allowed
to sleep with the husband with the same bed, in this way
the accused persons persistently increased physical as
well as mental torture upon your complainant and the
life of your complainant became very much troublesome and
then they started assaulting her in various ways with
the aim to force her to bring the aforesaid amount and fulfil the
demand of Rs. 1,00,000/- (Rupees One Lakh).

That, on 01/01/2024 at about 8.00 A.M. all the
accused persons assaulted your complainant by Lathi on her
back and all the accused persons drove your complainant
out from their house ever pouring Kerosene oil on
her body but anyhow the complainant saved her life, and
then your complainant took shelter in her father's house.
