I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sk Abdul Kadir**, **S/O–Sk Abdul Rajjak**, a permanent resident of **Vill:Gorabari**, **P.S -Neturia**, **Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **06.09.2024** at about **10:55AM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Sri Goutam Kumar Pandey, ACM both attached to Saltore CCC and others had been to the village Gorabari for routine inspection purpose. During inspection it was found that **Sk Abdul Kadir** was consuming electricity dishonestly and unauthorisedly in his domestic premises by one no .of 2 core 6sqmm black coloured aluminium pvc cable by the way of direct hooking so that less energy consumption recorded in energy meter which resulted causing loss of revenue of WBSEDCL in respect of **Consumer ID-2032222656**, **Meter No-BB0967684** to the tune of load **1.02KVA**.

As theft of electricity was detected during inspection the energy meter was disconnected & removed from the nearby electrical source and one numbers 2core black coloured 6 sqmm aluminium PVC cable approx 6meter has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list but the accused person denied by putting his signature in Seizure List. The service connection vide Con id- 203222656 was disconnected from pole side. The modus of operandi was video graphed. After completion of inspection, the inspection team left the aforesaid premises at about 11.15AM.

Thus the accused **Sk Abdul Kadir**, **S/O-Sk Abdul Rajjak Vill:Gorabari**, **P.S**-**Neturia**, **Dist- Purulia** have committed an offence **u/s** 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.
