Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Sukdeb Bouri, S/O- Anadi Bouri**, a permanent resident of **Vill :Ahirbari, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **06.09.2024** at about **12:24PM** I, Dhritiman Sardar S/O- Rupal Sardar aged about 26 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Sri Goutam Kumar Pandey ,ACM both attached to Saltore CCC and others had been to the village at Ahirbari for routine inspection purpose. During inspection it was found that Sri Sukdeb Bouri was consuming electricity dishonestly and unauthorisedly in his domestic premises by the way of direct hooking with one no of 2.5sqmm black coloured aluminium PVC Cable thus bypassing the energy meter without registering the actual consumption which resulted loss of revenue of WBSSEDCL in respect of **Consumer ID-202880217 ,Meter No-T02936678** to the tune of load **0.35KVA** .

As theft of electricity was detected during inspection the service connection was disconnected from the nearby electrical source and one number single core 2.5 sqmm aluminium PVC cable assorted size along with hooking device of has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Sukdeb Bouri acknowledged the same by putting his signature in the Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signature of the WBSSEDCL representative as well as the accused person has also been obtained on the label. The service connection vide Con id-**202880217** was disconnected from pole side. The modus of operandi was video graphed. After completion of inspection, the inspection team left the aforesaid premises at about **12:40 PM**.

Thus the accused **Sri Sukdeb Bouri, S/O- Anadi Bouri, Vill :Ahirbari, P.S -Neturia, Dist- Purulia** have committed an offence **u/s 135(1)(a)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
