Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sk Farhad, S/O-Sk Nur Hosen**, a permanent resident of **Vill:Nimdanga, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **11.09.2024** at about **02:15PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Goutam Kumar Pandey, ACM both attached to Saltore CCC and others had been to the village at Saltore for routine inspection purpose. During inspection it was found that **Sk Farhad** was consuming electricity dishonestly and unauthorisedly in his domestic premises by the way of direct hooking from the nearby LTOH line of WBSEDCL which resulted causing loss of revenue of WBSEDCL to the tune of load **1.12KVA**.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and one no of 2core 2.5sqmm faded yellow colored copper wire and some portion of 2core 1sqmm stranded black colored pvc copper wire assorted size along with one no of change over switch and two nos of porcelain 16A kitkat fuse unit has been seized under memo of seizure list in the presence of witnesses and accused person and their signature is also duly obtained in the seizure list, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives and accused person also obtained. The modus of operandi was video graphed. After completion of inspection, the inspection team left the aforesaid premises at about **02.30PM**.

Thus the accused **Sk Farhad, S/O-Sk Nur Hosen, Vill:Nimdanga, P.S -Neturia, Dist- Purulia** have committed an offence u/s **135(1)(a)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
