I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sk Farhad, S/O-Sk Nur Hosen, a permanent resident of Vill:Nimdanga, P.S -Neturia, Dist- Purulia has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 11.09.2024 at about 02:15PM I, Dhritiman Sardar S/O- Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Goutam Kumar Pandey, ACM both attached to Saltore CCC and others had been to the village at Saltore for routine inspection purpose. During inspection it was found that Sk Farhad was consuming electricity dishonestly and unauthorisedly in his domestic premises by the way of direct hooking from the nearby LTOH line of WBSEDCL which resulted causing loss of revenue of WBSEDCL to the tune of load 1.12KVA.
