Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Patit Bauri (56 yrs) S/O- Lt. Sudhir Bauri of Vill-Bhamuria, PS-Neturia, Dist-Purulia with seizure of 12 pcs sealed bottles of CAPTAIN Country spirit containing 375 ml each (MRP @ Rs. 100/-) which were seized under proper seizure list.

I beg to submit that today (13.09.2024) while I, SI Saurav Kanti Das of Neturia PS, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-621 Dt. 13.09.2024 & CC No-2504/24 Dt. 13.09.24 and acting on source information after consulting you at about 20:25 hrs reached at Areakusum and held raid in Kalimela Hotel cum Dhaba of Patit Bauri (56 yrs) S/O- Lt. Sudhir Bauri of Vill-Bhamuria, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his Hotel cum Dhaba, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 12 pcs sealed bottles of CAPTAIN Country spirit containing 375 ml each (MRP @ Rs. 100/-) which were seized under proper seizure list duly signed by witnesses under proper videography and out of it labeled 01 (One) bottle as sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 47 BNSS, 2023 and handed over a copy of the same to arrestee.

The arrested accused namely Patit Bauri (56 yrs) S/O- Lt. Sudhir Bauri of Vill-Bhamuria, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.




