Respected Sir,

In producing herewith one arrested accused person namely Shaktipada Orang (33 yrs) S/o Lt. Maheswar Orang of Vill- Bhandarkuli, PS-Para, Dist-Purulia with seized article i.e 13 (Thirteen) Pcs. sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (11.09.2024) during my Spl. Evening Mobile duty I received credible source information that one Shaktipada Orang (33 yrs) S/o Lt. Maheswar Orang of Vill- Bhandarkuli, PS-Para, Dist-Purulia was selling huge quantity of Country Spirit in his house. Accordingly, I informed to O/C Para PS and as per his instruction in between 19.35 hrs to 19.55 hrs. I held raid in his house and found that the above noted person was selling Country Spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying Country Spirit fled away. I asked the above noted person to produce license for selling such Country Spirit, but he did not have any authorization or license in support of said Country Spirit. As such he committed offence/46A(c) BE Act 1909 so he was arrested him U/S 67 BE Act and also seized 13 (Thirteen) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which were selling in which 01 (one) bottle as sample under proper seizure list in presence of witnesses duly signed by them. The seizure process made with proper videography & the memory card also been seized as produced the accompanied constable. I also prepared seizure list and label in presence of witnesses duly signed by them. During the time of arrested maintaining all rules and guideline as laid down by NHRC/WBHRC and informed his family members.

The arrested accd. namely Shaktipada Orang (33 yrs) S/o Lt. Maheswar Orang of Vill- Bhandarkuli, PS-Para, Dist-Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a specific case may kindly be started against Shaktipada Orang (33 yrs) S/o Lt. Maheswar Orang of Vill- Bhandarkuli, PS-Para, Dist-Purulia under proper section of law.
