Sub-F.I.R against Sri Nanda Gopal Gope, S/O-Hariram Gope, residing at Village-Dahibari, P.O-Bagda, P.S-Pancha, Dist-Purulia, Pin-723151, for unauthorized drawl of electricity by the way of bypassing of energy meter of W.B.S.E.D.C.L at his premises.

Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that against Sri Nanda Gopal Gope, S/O-Hariram Gope, residing at Village-Dahibari, P.O-Bagda, P.S-Pancha, Dist-Purulia, Pin-723151 has committed theft of electricity under section 135 clause 1(b) of Indian Electricity Act-2003, subsequently amendment act-2007 on at about 01.20 P.M.

I Sri Saikat Mallick, S/O-Himadri Mallick, A.E. & S.M. of Pancha CCC along with 1) Sri Somnath Soren (J.E Gr-I) under Pancha CCC, S/O-Lt. Pannaial Soren 2) Sri Sandip Mahato (Sr.O.E.) under Pancha CCC, S/O-Lt. Brindaban Mahato, 3) Soumajit Rakshit (O.E.), under Pancha CCC, S/O-Sanjit Kumar Rakshit, 4) Sri Sukumar Dutta (Sr.T.S.H.), under Pancha CCC, S/O-Lt. Jitendranath Dutta, 5) Sristidhar Mahato (Sr.T.S.H.) under Pancha CCC, S/O-Lt. Ganesh Mahato and other technical staff attached to Pancha CCC entered the premises of Sri Nanda Gopal Gope, S/O-Hariram Gope, residing at Village-Dahibari, P.O-Bagda, P.S-Pancha, Dist-Purulia, Pin-723151, consumer of Pancha CCC having Consumer ID- 242120751, Meter No- LG0264280 and inspected his premises. During the inspection theft of electricity was detected by the way of bypassing of energy meter of WBSEDCL with serial no- LG0264280 under section 135 clause 1(b) of Indian Electricity Act-2003, subsequently amendment act- 2007.

The accused person was consuming electricity dishonestly at his domestic premises by the way of bypassing of energy meter of WBSEDCL without registering the actual consumption by inserting wire from incoming port of energy meter causing considerable revenue loss of WBSEDCL. During inspection total load was found 2.21KW. From the above bypassing system he uses the following electrical equipment

1) AC (Air Conditioner)-01 no (1500Watt), 2) Fan-04 nos (80Watt each), 3) Light-08 nos (30Watt each), 4) Fridge-01 no (150Watt)

The following items were seized from the house of the accused person-

1) 1 no. single phase energy meter bearing serial no-LG0264280 with broken seal missing
2) 2 core PVC cable 12 meter approx. 3) Electrical changeover

Seizure list was prepared at the site and the accused person refused to sign. The inspection team left the premises at about 01:40 P.M. on 06.09.2024. The accused person has committed an offence u/s 135 clause 1(b) of I.E Act-2003, subsequently amendment act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
