Sub: Prayer for lodging FIR under proper section of law.

Sir,

In producing herewith the arrested accused driver namely Dhurendranath Mahato (49 Yrs) S/o- Biswanath Mahato of Vill- Garafusro, PS- Purulia (M), Dist- Purulia along with seized Tractor having registration No- WB 55A 8010 attached with trolley loaded with sand approx 100 cft each, Seizure list and Memo of Arrest.

I beg to state that today 03.09.2024 I, SI Aniruddha Chatterjee along with force (i) C/- 531 Shib Shankar Mahanty (ii) C/- 248 Arabinda Roy of Purulia (M) PS left the PS for performing evening night mobile duty vide Purulia (M) PS GDE No- 177, Dtd. 03.09.2024 in PS area. During my mobile duty, on 04.09.2024 at about 02.05 hrs I received a tip off that onr suspicious tractor loaded with sand was coming from Chasmorh side towards Purulia. Subsequently, I along with officer and force proceeded toward Imundih morh to work out the tip off. While, myself along with force arrived at Imundih morh under Purulia (M) PS, found that one Tractor coming from Chasmorh side. Accordingly, I along with force intercepted the Tractor bearing Reg. No- WB 55A 8010 attached with trolley loaded with sand approx 100 cft each at about 02.35 hrs and detained one person who was driving the said tractor. I found that the vehicle as well as goods was identical as I received prior information. On being asked, the driver of the Tractors disclosed his identity as Dhurendranath Mahato (49 Yrs) S/o- Biswanath Mahato of Vill- Garafusro, PS- Purulia (M), Dist- Purulia and also stated that he is the driver of said Tractor. I asked the driver of the Tractor to produce the valid documents in respect of the Tractor as well as the loaded sand. But the driver of the said Tractor was not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked him to produce the valid papers but he stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned

to believe that the alleged driver in cahoots with the owner of the Tractor procured the said sand from Kantabera Sand Ghat by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized one Tractor bearing Reg. No- WB 55A 8010, attached with trolley loaded with sand approx 100 cft from the possession of Dhurendranath Mahato S/o- Biswanath Mahato of Vill- Garafusro, PS- Purulia (M), Dist- Purulia under proper seizure list in presence of available witnesses duly signed by them. The seizure was done between 02.45 & 03.05 hrs. The whole process of raid, seizure, labelling, arrest, has been videography.

Also arrested the alleged driver namely Dhurendranath Mahato (49 Yrs) S/o- Biswanath Mahato of Vill- Garafusro, PS- Purulia (M), Dist- Purulia after informing him the ground of arrest and issued Memo of Arrest against him and also issued Check List. Thereafter, I brought the seized tractor and alleged arrested driver to Purulia (M) PS.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the owner of seized Tractor bearing Reg. No- WB 55A 8010 attached with trolley loaded with sand approx 100 cft each and the arrested driver namely Dhurendranath Mahato (49 Yrs) S/o- Biswanath Mahato of Vill- Garafusro, PS- Purulia (M), Dist- Purulia under proper section of Law.
