Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Nimal Rajwar (59 Yrs) S/o- Lt. Bipin Rajwar of Vill- Bhul, PS- Purulia (M), Dist- Purulia and seized 17 (Seventeen) numbers of sealed bottles of Country Spirit styled as "DIL KHUSH" containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (15.09.2024) during my mobile duty at about 15:15 hrs I, ASI Sujit Mondal of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor near Lagda village under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 564 Prahad Majhi & C/- 1182 Santosh Kr. Mahato of Purulia (M) PS vide GDE No- 911, Dtd. 15.09.2024 rushed to the spot i.e. in an abandoned room situated beside the Purulia Ranchi High Way near Lagda village under Purulia (M) PS at 15:35 hrs. After arriving at that spot and as per your instruction we conducted a raid in the said abandoned room. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Nimal Rajwar (59 Yrs) S/o- Lt. Bipin Rajwar of Vill- Bhul, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in the abandoned room for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of Country Spirit styled as "DIL KHUSH" containing 600 ml each. In which 01 sealed bottle was taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was done between 15:45 to 16:15 hrs.

I also arrested the involved accused person namely Nimal Rajwar (59 Yrs) S/o- Lt. Bipin Rajwar of Vill- Bhul, PS- Purulia (M), Dist- Purulia after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Nimal Rajwar (59 Yrs) S/o- Lt. Bipin Rajwar of Vill- Bhul, PS- Purulia (M), Dist- Purulia under proper section of Law.
